Salisbury man arrested for his part in last week's assault with firearm that occurred on Prince St.

On May 8, 2025, just after midnight, officers of the Salisbury Police Department responded to Tidal Health Peninsula Regional to meet with a victim who had allegedly been shot. Upon arrival, officers met with a 14-year-old male victim who was suffering from an apparent gunshot.

The initial investigation conducted by Salisbury Police officers and detectives revealed that the victim and the suspect were together within the 400 block of Prince St. A confrontation erupted between the victim and the suspect, who allegedly brandished and discharged a firearm striking the victim one time. The suspect then fled from the scene in a vehicle. The victim was transported to Tidal Health Peninsula Regional, and later Shock Trauma in Baltimore, where he was treated for a single gunshot wound to his neck. The victim's injuries were considered life-threatening; however, his condition is now stable.

Through the course of the investigation, detectives were able to identify 22-year-old Dorrian Clayborne as the shooting suspect in this incident. An application for charges was presented to the District Court Commissioner's Office wherein an arrest warrant was issued for Mr. Clayborne.

On May 13, 2025 at approximately 7:00 in the morning, members of the Capital Area Regional Fugitive Task Force (CARFTF) located Mr. Clayborne in a residence within the 600 block of N. Westover Dr. wherein he was taken into custody without incident. Mr. Clayborne was transported to the Salisbury Police Department and later released to the Wicomico County Detention Center.

The Salisbury Police Department would like to thank the Wicomico County Sheriff's Office and CARFTF for their assistance in this investigation. CARFTF is an interjurisdictional law enforcement unit consisting of members of the US Marshals Service, Maryland State Police, Salisbury Police Department, and the Division of Parole and Probation (Salisbury Field Office).
