

CITY OF SALISBURY, MARYLAND FY 2026 COMMUNITY DEVELOPMENT BLOCK GRANT (CDBG) PROGRAM DRAFT DISPLAY OF THE FY 2026 ANNUAL ACTION PLAN

Notice is hereby given that the City of Salisbury, MD will hold a public hearing on **Thursday, May 7, 2026 at 3:00 PM**, in the Council Chambers, Government Office Building, Room 301, 125 N Division Street. The Council Chambers are accessible to persons with mobility limitations. If special arrangements need to be made to accommodate any resident in order for them to participate in the public hearing, including translation services, please call Ms. Olga Butar, Grant Administrator/Project Manager, Finance Department, City of Salisbury, (410) 548-3110 or obutar@salisbury.md, to make those arrangements. The hearing will additionally be broadcast live on PAC-14 and then uploaded to You Tube for future viewing.

The purpose of this public hearing is to present the draft FY 2026 Annual Action Plan. The City of Salisbury will receive a Federal Community Development Block Grant (CDBG) allocation from the U.S. Department of Housing and Urban Development (HUD) in the amount of \$367,754 for FY 2026. The City proposes to fund the following activities: Street Improvements in the amount of \$294,204 and CDBG Program Administration in the amount of \$73,550.

At the public hearing on May 7, 2026, the Grants Administrator/Project Manager will discuss the development of the plan, as well as the needs and goals identified in the plan. It will also include a report on the status of the previously funded CDBG projects that are currently open. This hearing will provide residents with an opportunity to comment and provide their views on the low- and moderate-income needs of the City of Salisbury. All interested parties are encouraged to attend and provide input.

In order to obtain the views of residents, public agencies and other interested parties, the City has placed the FY 2026 Annual Action Plan on display for 30 days beginning Thursday, April 9, 2026 and ending on Monday, May 11, 2026, at the following locations: the Government Office Building, 125 N Division Street, Room 103, Salisbury, MD 21801, between the hours of 8:30am – 4:30pm and on the City's website: <https://salisbury.md/>.

This document will be available to the public during normal hours of operation for a period of thirty (30) days until Monday, May 11, 2026, after which time the FY 2026 Annual Action Plan will be submitted to City Council for approval.
