

ORDINANCE NO. 2994

AN ORDINANCE OF THE CITY OF SALISBURY APPROVING A BUDGET AMENDMENT OF THE FY2026 GENERAL FUND BUDGET TO APPROPRIATE \$7,198.00 TO THE FIELD OPERATIONS' OPERATING BUDGET FOLLOWING RECEIPT OF INSURANCE PROCEEDS FOR A DAMAGED TRAFFIC UNIT POST PULLER.

WHEREAS, the City's Department of Field Operations sustained damage to a traffic unit post puller;
and

WHEREAS, the City has received insurance reimbursement in the amount of \$7,198.00 for the damaged equipment and has deposited these funds into the City's General Fund; and

WHEREAS, the Department of Field Operations has a need to replace the damaged traffic unit post puller and requests that these funds be reallocated to the Field Operations Operating Budget for FY2026; and

WHEREAS, the budget amendment as provided herein must be made upon the recommendation of the Mayor and the approval of four-fifths of the Council of the City of Salisbury.

NOW, THEREFORE, BE IT ENACTED AND ORDAINED BY THE COUNCIL OF THE CITY OF SALISBURY, MARYLAND, as follows:

Section 1. The City of Salisbury's Fiscal Year 2026 General Fund Budget be and is hereby amended as follows:

(a) Increase the Insurance Proceeds Account (01000-456935) by \$7,198.00; and

(b) Increase the Field Operations Operating Budget (Account Number: 30000-546006) by \$7,198.00.

BE IT FURTHER ENACTED AND ORDAINED BY THE COUNCIL OF THE CITY OF SALISBURY, MARYLAND, as follows:

Section 2. It is the intention of the Mayor and Council of the City of Salisbury that each provision of this Ordinance shall be deemed independent of all other provisions herein.

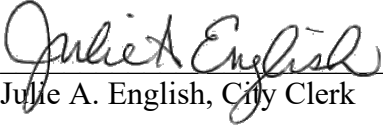
Section 3. It is further the intention of the Mayor and Council of the City of Salisbury that if any section, paragraph, subsection, clause, or provision of this Ordinance shall be adjudged invalid, unconstitutional, or otherwise unenforceable under applicable Maryland or federal law, such adjudication shall apply only to the section, paragraph, subsection, clause, or provision so adjudged, and all other provisions of this Ordinance shall remain and shall be deemed valid and enforceable.

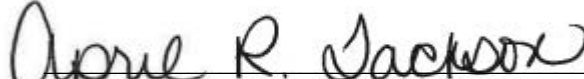
Section 4. The recitals set forth hereinabove are incorporated into this section of the Ordinance as if such recitals were specifically set forth at length in this Section 4.

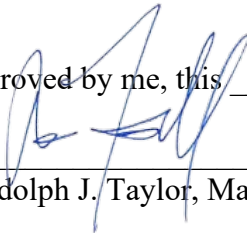
Section 5. This Ordinance shall take effect from and after the date of its final passage.
