A RESOLUTION OF THE COUNCIL OF THE CITY OF SALISBURY ACCEPTING FUNDS IN COOPERATION WITH THE MARYLAND OFFICE OF HIGHWAY SAFETY TO PROVIDE FOR OVERTIME REIMBURSEMENT TO POLICE OFFICERS PARTICIPATING IN A SPECIAL ENFORCEMENT PROGRAM, "SMOOTH OPERATOR", TO REDUCE THE OCCURRENCE OF UNSAFE AND UNLAWFUL ACTIONS OF DRIVERS WHO DEMONSTRATE A CONSCIOUS AND WILLFUL DISREGARD OF TRAFFIC SAFETY.

WHEREAS, the Maryland Office of Highway Safety and the Salisbury Police Department will cooperate successfully in serving the people of Salisbury/Wicomico County and;

WHEREAS, grant funding has been designated for proactive enforcement efforts targeting aggressive driving, defined as a combination of unsafe and unlawful actions that demonstrate a conscious and willful disregard of safety, to include running red lights and stop signs, following too closely or tailgating, changing lanes unsafely, failing to yield the right of way, improper passing and speeding;

WHEREAS, enforcement efforts will be complemented by a comprehensive public education campaign that includes radio ads, tv ads and billboards;

WHEREAS, the use of overtime funds will allow increased police presence for waves of special aggressive driving enforcement to target reducing the occurrence of drivers operating a motor vehicle while demonstrating a conscious disregard of safety.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF SALISBURY, MARYLAND that grant funds in the amount of \$7,000.00 be accepted and used for overtime reimbursement to reduce the occurrence of drivers operating a motor vehicle demonstrating a conscious disregard of safety.
