## RESOLUTION NO. 1263

A RESOLUTION of the Council of the City of Salisbury authorizing the application of Chapter 205 of the Wicomico County Code to taxicabs operated within the City limits of the City of Salisbury.

WHEREAS, Section 205-3 of the Wicomico County Code provides that Chapter 205, regarding the regulation of the taxicab industry, may be made applicable within the corporate limits of any municipality which so requests, provided that an appropriate agreement has first been executed between the County and the Municipality;

WHEREAS, by Resolution No. 670, effective October 11, 1999, the Council of the City of Salisbury authorized the Wicomico County Sheriff's Office to regulate and enforce the taxi industry within the limits of the City of Salisbury, Maryland, in accordance with Wicomico County Code, Chapter 205;

WHEREAS, the Council of the City of Salisbury desires to clarify that the provisions of Chapter 205 of the Wicomico County Code apply to all taxicabs operating within the City limits of the City of Salisbury and approve the agreement made between the County and the City with regard to regulation and enforcement;

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Salisbury, Maryland, that the provisions of Chapter 205 of the Wicomico County Code apply within the City limits of the City of Salisbury and that the agreement made between Wicomico County and the City of Salisbury on \_\_\_\_\_\_\_, with regard to the regulation and enforcement of the taxicab industry is approved.

## **AGREEMENT**

This Agreement made this \_\_\_\_\_ day of \_\_\_\_\_\_, \_\_\_\_, by and between the City of Salisbury (hereinafter "City") and Wicomico County Council (hereinafter "County").

WHEREAS, Wicomico County has enacted Chapter 205 of the Wicomico County Code, which is an ordinance regulating all taxicabs operated within Wicomico County;

WHEREAS, §205-3 of the Wicomico County Code provides that Chapter 205 may be made applicable within the corporate limits of any municipality which so requests, provided that an appropriate agreement has first been executed between the County and the Municipality;

WHEREAS, the City of Salisbury desires to ensure that owners and operators of taxicabs comply with the regulations set forth in Chapter 205 of the Wicomico County Code;

NOW, THEREFORE, in consideration of the foregoing recitals and the exchange of promises set forth herein, the parties hereby covenant and agree as follows, as of the effective date hereof.

- 1. That Chapter 205 of the Wicomico County Code, regarding the regulation of the taxicab industry, is applicable within the corporate limits of the City of Salisbury.
- 2. That the Wicomico County Sheriff's Office is authorized to regulate the taxicab industry within the limits of the City of Salisbury, Maryland, and enforce the regulations set forth in Chapter 205 of the Wicomico County Code.

3. That the Salisbury City Police Department is also authorized to enforce the regulation of the taxicab industry within the City limits of the City of Salisbury pursuant to an ordinance which shall hereafter be enacted by the Council of the City of Salisbury.
