501 E. Church Street (Zorro Property)

Attached, please find a Resolution to accept the transfer of seized and forfeited real property located 501 E. Church Street (the Zorro property) from the Department of the Treasury to the City of Salisbury.

Weed & Seed is founded on the premise that community organizations, social service providers and criminal justice agencies work together with community residents to regain control and revitalize crime ridden and drug-plagued neighborhoods. The Department of the Treasury Executive Office for Asset Forfeiture Directive number 9 establishes guidelines and authorizes the transfer of seized and forfeited real property to states and political subdivisions in support of the Weed & Seed initiative. The real property known as 501 E. Church Street falls under the guidelines of this Directive.

On April 19, 2005, BHZ certified that to the best visible constraints, the physical inspection of the property revealed no significant structural fault or assembly in need of repair/replacement. BHZ's overall score of the structure on a 1 through 5 scale was 3.5. While no decision has yet been reached as to the use of this property, several ideas have been discussed. The building could be used as a community meeting room, a police substation, etc., but again has to be used in support of the Weed and Seed initiative.
