The Public Works Department requests that the attached Resolution accepting \$ 262,000 in donations from the Delmarva Zoological Society to partially fund the construction of the Animal Health Clinic at the Salisbury Zoological Park be added to the next available City Council meeting agenda.

The Salisbury Zoological Park, to maintain accreditation, will construct an animal health building on the southwest corner of the Zoo property. Just a few things this building will offer are: a zoo office, veterinary office, surgery and treatment room and house animals during treatment and quarantine periods.

To date, the funding source for this project is the \$500,358.31 City of Salisbury Public Improvement Bond of 2009.

The animal health building was divided into (3) phases to allow for phased construction of the building providing the City of Salisbury did not have the funding to construct the building in its entirety upon bid acceptance.

Phase I: All site prep work and construction of the geothermal well field.

Phase II: Construct building foundation, construct building shell with roof and roof covering, rough in all mechanical, plumbing and electrical systems, construct all walks and paving.

Phase III: Complete interior walls, doors, plumbing and electrical

With acceptance of these funds, we plan to construct both Phase I and II of this project.
